PETITION FOR ADMINISTRATION

Petitioner, GARRICK T. SKALSKI, alleges:

1. Petitioner has an interest in the above estate as son and beneficiary of the decedent.

5. GARRICK T. SKALSKI is entitled to preference in appointment as personal representative because he is the son of the decedent and he was appointed to serve as personal representative in the Will of the decedent. Daughter of the decedent is entitled to equal preference and will be served with formal notice of this petition or will submit a signed consent for the appointment of GARRICK T. SKALSKI as personal representative.

6. GARRICK T. SKALSKI is qualified under the laws of the State of Florida sections 733.302, 733.303 and 733.304 to serve as personal representative of the decedent's estate: he is over the age of eighteen years, he is a resident of the state of Florida, he has not been convicted of a felony, and he is mentally and physically able to perform the duties as personal representative.

10. After the exercise of reasonable diligence, petitioner is unaware of any unrevoked wills or codicils of decedent, other than set forth in paragraph 9.

11. Domiciliary or principal probate proceedings are not known to be pending in another state or country.

Petitioner requests that decedent's Will be admitted to probate and that GARRICK T. SKALSKI be appointed personal representative of the estate of the decedent.
