
Effective January 21, 1993, the Ohio General Assembly adopted R.C. 2301.03(T) and created the division of domestic relations of the Allen County Common Pleas Court and directed that the judge of that division be assigned "all divorce, dissolution of marriage, legal separation and annulment cases, all cases arising under Chapter 3111. of the Revised Code, all proceedings involving child support, the allocation of parental rights and responsibilities for the care of children and the designation for the children of a place of residence and legal custodian, parenting time, and visitation, and all post decree proceedings and matters arising from those cases and proceedings, except in cases that for some special reason are assigned to another judge of the court of common pleas." However, pursuant to the provisions of R.C. 2151.23(A)(2), (A)(11), and (B)(2)-(B)(9), the judges of the Juvenile Division have continued to exercise jurisdiction and hear proceedings and post decree proceedings arising under Chapter 3111., and proceedings involving child support and the allocation of parental rights, parenting time and visitation relating to children born to unmarried persons. In consultation with the judge of the Domestic Relations Division of the Common Pleas Court, it has been determined that those matters should now more properly be assigned and heard by the judge of the Domestic Relations Division as contemplated by R.C. 2301.03(T).


IT IS THEREFORE ORDERED, in accordance with R.C. 2301.03(T), that effective July 1, 2020, all cases arising under Chapter 3111. of the Revised Code, all proceedings involving child support, the allocation of parental rights and responsibilities for the care of children and the

designation for the children of a place of residence and legal custodian, parenting time, and visitation, including pending original actions and post decree proceedings, when transferred by the Juvenile Court, and matters arising from those cases and proceedings, are assigned to be heard by the judge of the Domestic Relations Division of the Common Pleas Court of Allen County, Ohio. The Juvenile Division will retain continuing jurisdiction over post-decree proceedings relating to parenting time, visitation, child support, and legal custody in those cases in which a child has been adjudicated dependent, neglected, or abused until the Juvenile Division expressly relinquishes jurisdiction by Entry.

IT IS FURTHER ORDERED that all cases hereafter initiated in the Common Pleas Court of Allen County, Ohio and arising under Chapter 3111. of the Revised Code, all proceedings involving child support, the allocation of parental rights and responsibilities for the care of children and the designation for the children of a place of residence and legal custodian, parenting time, and visitation, and all post decree proceedings and matters arising from those cases and proceedings shall be filed in the Domestic Relations Division of the Court, and assigned to the judge of the Domestic Relations Division in accordance with Revised Code 2301.03(T).
